RAFFLE REGULATIONS – EXTENSION OF TICKET SALE PERMISSIBILITY

This amendment would extend the number of days for which raffle ticket sales may be offered before the actual raffle drawing from the current 180 days to 270 days. Many seasonal raffles (i.e., Minocqua Musky Tournament) are major tourism events with year-long planning activities. This year, the scheduled fishing tournament in Minocqua falls more than 180 days beyond the initial kick off celebration. Extending the number of days for which these tickets may be sold poses no threat to consumer protection and better accommodates the reality and necessity of today's private fundraising activities.

Tickets for a proposed raffle may be offered for sale more than ~~180~~ 270 days before the raffle drawing.
