1 At the locations indicated, amend the bill as follows:

2 1. Page 388, line 13: after that line insert:

3 “(8x) FUNDING FOR CERTAIN PAY ADJUSTMENTS. Notwithstanding section 20.928
4 (1) of the statutes, during the 2001-03 fiscal biennium, no state agency, as defined
5 in section 20.001 (1) of the statutes, may include in any certification to the
6 department of administration under section 20.928 (1) of the statutes, and the
7 department of administration may not include in any determination forwarded to
8 the joint committee on finance under section 20.928 (2m) of the statutes, any sum to
9 pay the cost of a pay adjustment for an employee in a position that is at the higher

1 end of the pay scale for state employee positions, as determined by the department
2 of administration.”.

3 **2.** Page 455, line 4: before that line insert:

4 “(8x) COMPENSATION RESERVE REDUCTIONS. When amending the schedule and
5 summaries under section 20.004 (2) of the statutes, in addition to making any other
6 reduction required by law, the department of administration shall reduce the
7 amount that appears in the summary table entitled “Summary of Compensation
8 Reserves — All Funds” under section 20.005 (1) of the statutes in 2001 Wisconsin Act
9 16, and adjust all totals accordingly, for each of the following types of revenue by the
10 amounts indicated for that fiscal year:
