Analysis by the Legislative Reference Bureau

Under current law, the Dane County regional planning commission (DCRCP) is to be dissolved on October 1, 2002. Under this bill, the DCRCP shall be dissolved on October 1, 2004.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 4. 1999 Wisconsin Act 9 section 9158 (8w) (e) is amended to read:

[1999 Wisconsin Act 9] Section 9158 (8w) (e) Notwithstanding the procedures for dissolution of a regional planning commission that are specified under section 66.945 (15) of the statutes, the Dane County regional planning commission shall be dissolved on October 1, 2002 2004. All unexpended funds of the commission on that
