1 At the locations indicated, amend the bill as follows:

2 ↓ 1. Page 7, line 22: delete "local unit of government" and substitute "city or
3 village".

4 ↓ 2. Page 7, line 23: delete "local unit of" and substitute "city or village".

5 ↓ 3. Page 7, line 24: delete "government".

6 ↓ 4. Page 7, line 25: delete "local unit of government" and substitute "city or
7 village".

8 ↓ 5. Page 8, line 1: after the period insert "If any part of a town is not under the
9 jurisdiction of a regional planning commission, the county shall either map the
10 upland environmental corridors within the boundaries of the town or shall contract
11 with a regional planning commission to perform the mapping.".
