PRELIMINARY DRAFT—NOT BEADY FOR INTRODUCTION.

AN ACT ...; relating to: a certain highway improvement project on USH 51 in the

city of Madison.

Analysis by the Legislative Reference Bureau

This bill requires the department of transportation, during the 2001-03 fiscal biennium, to expend funds not exceeding \$300,000 for a highway improvement project on USH 51 at the intersection of Rieder Road in the city of Madison. The project may only be funded from federal funds available under the federal hazard elimination program, which provides funds for highway safety improvement projects, and funds may be expended only if the project is consistent with the requirements of, and regulations promulgated under, the federal hazard elimination program. The project must include construction of certain specified traffic lanes and installation of certain specified traffic control signals.

For further information see the state and local fiscal estimate, which will be

printed as an appendix to this bill.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

The project shall include reconstruction of the southbound lanes of USH 51 at Rieder Road to incorporate a divided deceleration and turn lane on USH 51 for

TECHNICAL MEMO

SB 242 (LRB 01-3721/1)

Prepared by the Department of Transportation

SB 242 requires the Department of Transportation to make certain geometric and traffic signal improvements at the intersection of USH 51 and Reider Road in the City of Madison.

On 8/31/2001, The Department of Transportation approved a Hazard Elimination project (HES) to improve the intersection of USH 51 and Reider Road. The project will reconstruct the intersection and will prohibit left turns from westbound Reider Road to southbound USH 51. All other traffic Movements will be allowed. The former westbound traffic movement on Reider Road will have access to southbound USH 51 via an access road to be constructed as part of the project. The access road will bring that traffic to the existing intersection of Kinsman Boulevard and USH 51 which currently has a traffic control signal in operation. The project is scheduled for calendar year 2004 construction. The estimated cost for this project is about \$750,000 with a cap of \$477,000 in HES funding.


In the current operation of the intersection, left turns from WB Reider Road to SB USH 51 are prohibited by construction barrels placed in the median. Left turn access from SB USH 51 into Reider Road is allowed.

In the 5 year and 3 month period from 1994 to March 1999, 21 crashes occurred at the intersection while all traffic movements were permitted. Since the placement of the construction barrels in March of 1999 to prohibit WB left turns from Reider Road to SB USH 51, only 2 crashes have occurred to date that the Department is aware of.

The HES project already approved by the Department does not include traffic control signals. The proposed SB 242 would require the Department to install traffic signals for the NB lanes of traffic at Reider Road. The Department is concerned that the installation of traffic control signals for NB traffic will actually increase traffic crashes for the NB lanes that were not or are not occurring with the former or current intersection operation. Rear end crashes in particular would be expected to occur because of the high operating speed of NB USH 51 traffic given the rural

character of the highway; and, because NB traffic on USH 51 will be required to stop as the traffic signal changes the right-of-way back and forth from green on USH 51 and red on Reider road to green on Reider Road and Red on USH 51. NB traffic does not stop now because there are no traffic control signals or other traffic control for that movement.

The proposed design under the approved HES project does allow for the continued operation of SB USH 51 traffic to turn left into EB Reider Road. During the 1994-1999 before period when 21 crashes occurred at the intersection with all traffic movements allowed, only one crash involved a SB USH 51 left turning vehicle and a NB USH 51 vehicle. There have been none in the after period, since March of 1999 to date.
