1 AN ACT *to repeal* 101.87 (3), *to renumber* 101.80 (1) and 101.80 (2); *to*
2 *renumber and amend* 101.865 (1), 101.87 (1) and 101.87 (2); *to amend*
3 subchapter IV (title) of chapter 101 [precedes 101.80], 101.84 (2), 101.86 (1) (a),
4 101.88 (1) and 101.88 (3); *to repeal and recreate* 101.87 (title); and *to create*
5 101.80 (2m), (3) and (4), 101.80 (6), 101.80 (9), 101.80 (10), 101.865 (1) (c),
6 101.866, 101.87 (1) (c), 101.87 (1) (d) (intro.), 101.87 (1) (f) 3. and 4., 101.87 (2)
7 (b), 101.87 (3m) and 101.875 of the statutes; **relating to:** licensing of
8 electricians and electrical contractors, regulation of electrical construction,
9 granting rule-making authority, and providing a penalty.

Analysis by the Legislative Reference Bureau

Under current law, the department of commerce (department) must administer a program for certifying electrical contractors and master, journeyman, and beginning electricians. However, current law does not require a person who works as an electrician or electrical contractor to be certified by the department. A city, village, town, or county, though, may enact an ordinance requiring this certification or requiring the electrician or contractor to obtain a license from the municipality.

With certain exceptions, this bill requires every person who performs electrical construction in this state to be licensed by the department as a master, journeyman,

SUBCHAPTER IV
INSPECTION OF ELECTRICAL
CONSTRUCTION AND CERTIFICATION
OF MASTER ELECTRICIANS,
ELECTRICAL CONTRACTORS, AND
JOURNEYMEN AND BEGINNING
ELECTRICIANS

SECTION 2. 101.80 (1) of the statutes is renumbered 101.80 (5).

SECTION 3. 101.80 (2) of the statutes is renumbered 101.80 (8).

SECTION 4. 101.80 (2m), (3) and (4) of the statutes are created to read:

101.80 (2m) "Apprentice electrician" means an apprentice under an electrician apprenticeship program that is operated in compliance with ch. 106 and recognized by the U.S. department of labor.

(3) "Electrical construction" means the installing, altering, repairing, planning, or laying out of electrical wiring, apparatus, or equipment.

(4) "Electrical contractor" means a person who undertakes or offers to undertake work that constitutes electrical construction or the supervision of electrical construction.

SECTION 5. 101.80 (6) of the statutes is created to read:

101.80 (6) "Personal supervision" means oversight, by a master or journeyman electrician licensed by the department, of electrical construction being performed, such that the master or journeyman electrician:

(a) Is present at the work site and provides personal supervision for the entire working day;

1 (b) Is immediately available to the person performing the electrical
2 construction at all times for assistance and direction;

3 (c) Reviews the electrical construction performed; and

4 (d) Is able to and does determine whether the electrical construction is
5 performed in compliance with this subchapter and any applicable rules promulgated

7 **SECTION 6.** 101.80 (9) of the statutes is created to read:

8 101.80 (9) “Residential property owner” means an individual who performs
9 electrical construction on premises that the individual owns and occupies as a
10 residence or owns and will occupy as a residence upon completion of the electrical
11 construction or the construction of the residence.

12 **SECTION 7.** 101.80 (10) of the statutes is created to read:

13 101.80 (10) “Wisconsin State Electrical Code” means the rules promulgated by
14 the department under this subchapter.

15 **SECTION 8.** 101.84 (2) of the statutes is amended to read:

16 101.84 (2) At the request of the owner or tenant, enter, inspect and examine
17 the exterior and interior wiring of a public building or place of employment necessary
18 to ascertain compliance with the ~~rules promulgated under this subchapter~~
19 Wisconsin State Electrical Code.

20 **SECTION 9.** 101.86 (1) (a) of the statutes is amended to read:

21 101.86 (1) (a) Exercise jurisdiction over electrical construction and inspection
22 of electrical construction in public buildings and places of employment by passage
23 of ordinances, ~~providing such ordinances.~~ Ordinances enacted under this paragraph
24 may not be less restrictive than this subchapter and shall meet the minimum
25 requirements of the department’s rules adopted under this subchapter Wisconsin

1 State Electrical Code. No ordinance may require an electrical contractor who has
2 filed a bond under s. 101.866 (1) (a) 3. to maintain a bond as a condition of the
3 electrical contractor undertaking work in a municipality. A county ordinance shall

5 ordinance.

17 the electric current. The proof of compliance shall consist of a certificate furnished

25 occupying the building or permitting the building to be occupied. This proof of

6 Except as provided under sub. (3) and s. 101.87 (3m), no person may act as an
7 electrical contractor in this state unless the person satisfies all of the following:

8 1. The person has an electrical contractor's license issued by the department.

9 An electrical contractor's license does not authorize the licensee to physically
10 perform electrical construction.

11 2. The person is a master electrician licensed by the department or employs a
12 master electrician licensed by the department who is responsible, under the terms
13 of employment, for the performance and supervision of all electrical construction
14 undertaken by the electrical contractor. If the electrical contractor employs a
15 licensed master electrician, the licensed master electrician may not be employed as
16 an electrician by any other electrical contractor or by any person described under
17 sub. (3).

18 3. The person files with the department, and maintains, a bond endorsed by a
19 surety company authorized to do business in this state of not less than \$5,000,
20 conditioned upon the electrical contractor's ensuring that all electrical construction
21 the electrical contractor undertakes complies with the Wisconsin State Electrical
22 Code. The bond shall be for the benefit of persons damaged by reason of a failure to
23 so comply.

24 4. The person maintains either a policy of general liability insurance insuring
25 the person in the amount of at least \$100,000 per occurrence and \$300,000 aggregate

1 for bodily injury to or death of others because of electrical construction undertaken
2 by the person, and a policy of insurance insuring the person in the amount of at least
3 \$25,000 for damage to property because of electrical construction undertaken by the

5 per occurrence and \$300,000 aggregate for damage to property and bodily injury to
6 or death of others because of electrical construction undertaken by the person. Each
7 policy of insurance shall be issued by an insurer authorized to do business in this

9 indicating that the person is in compliance with the applicable portion of this
10 subdivision. An insurer may not cancel a policy of insurance that is the subject of
11 such a certificate unless the insurer provides written notice of cancellation to the
12 department at least 15 days before the date of cancellation.

13 (b) All written requests for permits and inspection made by an electrical
14 contractor shall be signed by a master electrician who satisfies par. (a) 2.

15 (2) Except as provided under sub. (3), no person may perform electrical
16 construction in this state unless the person is licensed by the department as a master,
17 journeyman, or beginning electrician or is an apprentice electrician. The
18 department, by rule, may specify the type of electrical construction that a master,
19 journeyman, or beginning electrician or apprentice electrician is authorized to
20 perform, except as follows:

21 (a) A master electrician may perform any work that a journeyman electrician
22 may perform.

23 (b) An apprentice electrician may perform any work that a beginning
24 electrician may perform.

1 (c) No apprentice electrician or beginning electrician may perform electrical
2 construction unless, at all times during which the electrical construction is
3 performed, at least one master or journeyman electrician licensed by the department

16 (d) A person engaged in planning, installing, maintaining, or repairing wiring,
17 apparatus, or equipment for elevators or escalators.

18 (e) A public utility, as defined under s. 196.01 (5), a cooperative association
19 organized under ch. 185 for the purpose of producing or furnishing heat, light, power,
20 or water to its members only, a telecommunications carrier, as defined in s. 196.01
21 (8m), a commercial mobile radio service provider, as defined in s. 196.01 (2g), or an
22 alternative telecommunications utility under s. 196.01 (1d), and any person who is
23 employed by or a subcontractor of such an entity and who is engaged in electrical
24 construction within the scope of the person's employment or contract.

2 and systems operating at 50 volts or less and any person who is employed by such

10 communications circuits or communications cabling.

11 (i) A person who is engaged in planning, installing, maintaining, or repairing
12 manufactured systems designed to provide a function to a building that is not
13 primarily electrical in nature. This paragraph does not apply to a person who is
14 engaged in planning, installing, maintaining, or repairing wiring that delivers
15 electric current to a manufactured system.

18 department for a waiver of the requirements of sub. (1) or (2), as appropriate, on the
19 grounds of prolonged illness, disability, or similar circumstances. The department
20 shall consider each application for a waiver under this subsection individually on its
21 merits and may grant a waiver for any meritorious application.

16 by this act, the department of commerce shall license as a journeyman electrician any
17 person who applies for a journeyman electrician's license within one year after the
18 effective date of this subsection and who provides the department with sufficient
19 evidence that the person has at least 1,000 hours of experience in electrical
20 construction during each of at least 10 years.

21 (3) POSITION INCREASE. The authorized FTE positions for the department of
22 commerce, funded from the appropriation under section 20.143 (3) (j) of the statutes,
23 are increased by 1.0 PR position on the effective date of this subsection for the
24 administration of subchapter IV of chapter 101 of the statutes.
