

TO 2001 SENATE JOINT RESOLUTION 2

D-NOTE

1 **To create** section 26 of article I of the constitution; **relating to:** the right to fish,
2 hunt, trap, and take game (first consideration).
3 **Resolved by the senate, the assembly concurring, That:**
4 **SECTION 1.** Section 26 of article I of the constitution is created to read:
5 [Article I] Section 26. The people have the right to fish, hunt, trap, and take
6 game which shall be managed by law for the public good.
7 **SECTION 2. Numbering of new provision.** The new section 26 of article I of
8 the constitution created in this joint resolution shall be designated by the next higher
9 open whole section number in that article if, before the ratification by the people of
10 the amendment proposed in this joint resolution, any other ratified amendment has
11 created a section 26 of article I of the constitution of this state. If one or more joint
12 resolutions create a section 26 of article I simultaneously with the ratification by the
13 people of the amendment proposed in this joint resolution, the sections created shall
14 be numbered and placed in a sequence so that the sections created by the joint

1 resolution having the lowest enrolled joint resolution number have the numbers
2 designated in that joint resolution and the sections created by the other joint
3 resolutions have numbers that are in the same ascending order as are the numbers
4 of the enrolled joint resolutions creating the sections.

5 ***Be it further resolved, That*** this proposed amendment be referred to the
6 legislature to be chosen at the next general election and that it be published for 3
7 months previous to the time of holding such election.
