

3 team was recognized as the 2000-01 WBCA Academic National Champions for the
4 NCAA Division I level; and

6 win/loss record ^{the} since 1991-92 ^{season} with an overall record of 24 wins and 6 losses ¹
7 including a phenomenal home record of 12 wins and only ^{one} loss; and

8 Whereas, the team achieved an amazing 14-game winning streak ¹ the 3rd
9 longest in team history ¹ won the regular season Horizon League conference title for
10 the 4th consecutive year and reached the NCAA tournament for the 4th time in the
11 past 5 years; and

12 Whereas, the team ranked in the NCAA Division I top 25 in ⁶ ~~the~~ major categories ^v,
13 including ⁸ field goal percentage, 3-point field goal percentage, scoring margin,
14 3-point field goals made per game, and scoring defense; and

1 Whereas, senior forward Mandy Stowe has been commended for her success on
 2 and off the court in being named the Horizon League tournament's Most Valuable
 3 Player, as well as being selected to the Verizon Academic All-District V team; and

4 Whereas, Coach Kevin Borseth was recognized as the Horizon League's head
 5 women's basketball coach of the year for the ~~time~~^{3 1/2} time in the past 4 seasons and
 6 Coach Borseth reached an elite coaching milestone by recording 300 wins during the
