


13. Repeal "Farms for the Future" Fund

Explanation:

The department proposes to repeal the "farms for the future" program created under ss. 25.17(1)(f), 25.44 and 93.48, Stats. The Legislature created a "farms for the future" trust fund in 1991, primarily as a vehicle for receiving anticipated federal funding for the protection and preservation of farmland. However, the federal funding never materialized, and the trust fund has never been used. The Legislature established an initial trust fund balance of \$50 which has not changed since 1991.

Statutory Changes:

SECTION _____. 25.17(1)(f) of the statutes is repealed.

SECTION _____. 25.44 of the statutes is repealed, and the fund balance is lapsed to the general fund.

SECTION _____. 93.48 of the statutes is repealed.
