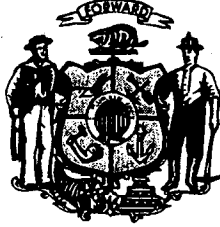

Subject: Department of Corrections Biennial Budget Request Statutory Language Drafts

I'm forwarding statutory language changes that the Department of Corrections (DOC) included with its budget submission.

- ✓ 1. New appropriation for Information Technology Master Lease Payments: This new appropriation will be used by the department to make master lease payments for the Integrated Corrections System and department IT equipment replacement. See Attachment 1.
- ✓ 2. Parole Commission Members: This change to s. 15.145(1) will increase the number of Parole Commission members from 6 to 8. See attachment 2.
- ✓ 3. Allocation of Byrne Law Enforcement Assistance/Penalty Assessment Funds: This change provides updated language regarding Byrne/penalty assessment funds to specify amount the department is requesting from the Office of Justice Assistance for the OWI 5th Offense program. See Attachment 3.
- ✓ 4. Establish New Institutions at Redgranite and New Lisbon: This change to s. 301.16(lr) and s. 301.16(ls) establishes medium security correctional facilities at Redgranite and New Lisbon. See attachment 4.
- ✓ 5. Deletion of Obsolete Appropriations: These changes eliminate obsolete appropriations from the department's Chapter 20 appropriation schedule. See attachment 5.

Topic: Deletion of Obsolete Appropriations

Current Language

The Department currently has several statutory appropriations that are no longer needed, including:

- §20.410(1)(cm) Home detention program
- §20.410(1)(fm) Offender release information
- §20.410(1)(j) State-owned housing maintenance
- §20.410(3)(o) Federal aid; foster care and treatment foster care

Proposed Change

Delete the following appropriations from the statutes:

- §20.410(1)(cm) Home detention program
- §20.410(1)(fm) Offender release information
- §20.410(1)(j) State-owned housing maintenance
- §20.410(3)(o) Federal aid; foster care and treatment foster care

Effect of the Change

These changes would eliminate these obsolete appropriations from the Department's Chapter 20 appropriation schedule.

Rationale for the Change

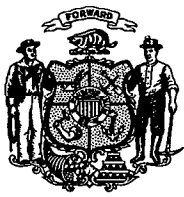
§20.410(1)(cm) Home detention program. This GPR appropriation has not used since the early 1990s. It was established for start-up of the program. There are no funds currently appropriated. Operating funds for the Department's monitoring center cover the expenses of obtaining, installing and monitoring equipment for the home detention program.

§20.410(1)(fm) Offender release information. This GPR appropriation was established to obtain computer software and provide offender release information to local law enforcement agencies who have been released to or placed in the agencies' jurisdiction. There are no funds currently appropriated in this appropriation. Ongoing funding for these activities are covered in DOC general operations appropriation.

§20.410(1)(j) State-owned housing maintenance. This PR-O appropriation was established for revenue received from the rental of state-owned housing at institutions for maintenance of the housing. There are no funds currently appropriated. There are no longer any housing units available at the institutions.

§20.410(3)(o) Federal aid; foster care and treatment foster care. This PR-F appropriation was established at the time of the transfer of juveniles to DOC. Because DHFS is the cognizant agency for federal foster care claims, DHFS claims foster care funds on behalf of DOC. DOC does not get the federal funds directly and therefore does not need this appropriation.
