One additional drafting request for the 2001-2003 biennial budget:

We are going to create a new Division in the Department of Workforce Development. It would contain the following programs:

- 1) National Community Services Board (currently attached to DOA)
- 2) Alliance for Wisconsin Youth (currently in DHFS)
- 3) Operation Fresh Start (currently in DOA)
- 4) Wisconsin Conservation Corps (currently in DWD)

✓ You could modify the existing draft (LRB 1768/1) that would have moved the NCSB to DHFS and use that as the base for the rest of the changes.

✓ Neither the Alliance or Operation Fresh Start appear to have any related statutory language.

WCC is currently program 6 within DWD and is authorized under s. 106.215.

Please rename program 6 within DWD "Community Services and Volunteerism". To reflect the greater diversity of this program, modify the following appropriations:

- 1) eliminate the reference to the Wisconsin conservation corps board in s.20.445(6)(c).
- 2) please change the name of s. 20.445(6)(m) to "Federal funds -- aid." Change the language in the appropriation to read along the lines of, "All monies received from the federal government as authorized under 16.54, including federal assistance for..."
- 3) please change the name of s. 20.445(6)(n) to "Federal funds - general program operations." In addition, change the appropriation language so that it reads similar to "All monies received from the federal government as authorized under s. 16.54 for general program operations including all moneys received under agreements..."
- 4) Change the name of 20.445(6)(kb) to "Funds received from other state agencies." Please strike the reference to agreements entered under 106.215(8)(I) and everything past the reference to par. K.

✓ In addition to the changes to the appropriation structure, there should be language that requires Operation Fresh Start and the Wisconsin Conservation Corps to jointly develop a plan that:

- 1) Tracks the educational attainment of participants
- 2) Consolidate functions
- 3) Add educational and training components
- 4) Determine the location and number of crews
- 5) Improve retention of crew members

EMPLOYMENT

Under current law, the national and community service board, which is attached to DOA for administrative purposes, administers at the state level the federal National and Community Service Trust Act of 1993, under which the federal government provides funding for national service programs that address unmet human, educational, environmental, and public safety needs and for educational grants to persons who successfully complete their term of service in a national service program. This bill transfers ~~this~~ board to DWD.

Under current law, the Wisconsin conservation corps (WCC) employs young adults to work on conservation and human services activities. This bill requires DWD and the WCC board to develop a plan to track the educational attainment of participants in the community service and volunteerism programs administered by DWD and the WCC board, consolidate the functions of DWD and the WCC board relating to those programs, add educational and training components to those programs, provide a method for determining the location and number of crews participating in those programs, and improve the retention of participants in those programs.

It seemed appropriate that the Wisconsin service corps should move to the community service and volunteerism program because the statutory structure of the program appears to be almost identical to that of the WCC. If you do not want that change, please advise and I will take it out.
2. Because program 6 is being broadened to include not only the WCC but also the National and Community Service Board and other nonstatutory programs, it was necessary to amend the titles of the current program 6 appropriations, other than s. 20.445 (6) (c) and (kb), stats., to clarify that those appropriations only apply to the WCC.

EMPLOYMENT

Under current law, the national and community service board, which is attached to DOA for administrative purposes, administers at the state level the federal National and Community Service Trust Act of 1993, under which the federal government provides funding for national service programs that address unmet human, educational, environmental, and public safety needs and for educational grants to persons who successfully complete their term of service in a national service program. This bill transfers that board to DWD.

Under current law, the Wisconsin conservation corps (WCC), which is administered by the WCC board, employs young adults to work on conservation and human services activities. This bill requires the WCC board to work with a nonprofit corporation that provides education, employment skills, and career direction leading to economic self-sufficiency to young people in Dane County who are at risk of not achieving economic self-sufficiency to develop a plan to track the educational attainment of persons enrolled in the WCC program, consolidate the functions of the WCC program, add educational and training components to the WCC program, provide a method for determining the location and number of crews working on WCC projects, and improve the retention of persons enrolled in the WCC program.



Gordon, I left a brief voicemail earlier, but here is a more complete description of changes that we'd like made to draft 1891/1. As I mentioned, a decision has been made to dissolve the WCC. In my discussions with the analysts over here that are familiar with the program, it appears that this will have to be a gradual phaseout. Here are things we would like to have drafted:

- 1) Forbid the WCC to accept new bids or form new crews following passage of the budget.
- 2) Following passage, the WCC may only hire new crew members to complete existing projects. Crew members hired under this provision may only be employed until the completion of the project.
- 3) On June 30, 2002, the WCC will be repealed (and all uncompleted projects will be terminated). *impairment of K?*
- 4) Require the WCC to calculate all outstanding education vouchers and encumber sufficient funds to meet these obligations before June 30, 2002.
