The intent of this request is to create a transfer of funds from the main tribal gaming revenue appropriation in the Department of Administration [s. 20.505 (8) (hm)] to the conservation fund for parks operations. The one-time transfer would be \$1,000,000 in fiscal year 2001-02 and \$718,000 in fiscal year 2002-03. The transfer should be repealed, or terminated, on June 30, 2003.
