Broader Fee Authorization

- The Society charges fees for admission to venues (e.g. historic sites), products it produces (e.g. books) or resell (e.g. gift shop merchandise) and services it provides (e.g. genealogical research services).
- In past discussions with the Department of Justice about the Society's authorization to charge fees, concerns have been raised that the specifics of existing language to charge or not charge fees limits the Society's ability to charge fees for subjects not mentioned in chapter 44.
- In order to provide more services desired by the public and more opportunities to respond to GPR budget reductions, the Society requests a broadening of its fee setting authority for existing services and new services to be developed (without having to develop an administrative rule for each fee).
