2. This draft does not contain the extra position (the 18.5th position) for DNR because I have not received information about from which appropriation it should be funded or about how much, if any, funding to provide for it. I can add the position in a redraft if there is time.
3. The draft changes s. 287.07 (7) (a) and requires DNR to promulgate rules to implement that change. It would probably be a good idea to add a delayed effective date for that change.
