DVA - Homes & Facilities for Veterans

Provide budget authority of \$368,500 PR and \$44,100 SEG in FY 02 and position authority of 28 FTEs and budget authority of \$1,998,300 PR and \$49,200 SEG in FY 03 for the purpose of funding the operation of the CBRF facilities at the new veterans home at the Southern Wisconsin Center.

Authority to construct a new building at SWC to be used as a CBRF was approved in the 1999-01 biennial budget. The DVA has since received approval from the United States Department of Veterans Affairs to fund up to 65% of the cost to construct the facility. Much of the planning and design work for the project has been completed and construction is scheduled to begin this fall. Current projections are that the facility will be completed in October 2001. The funding and position authority requested is needed to operate the new CBRF.


