The amendment is written incorrectly, as you noted, the intent is to provide 30,000 in each year to raise the amount from 150,000 to 180,000 per year.



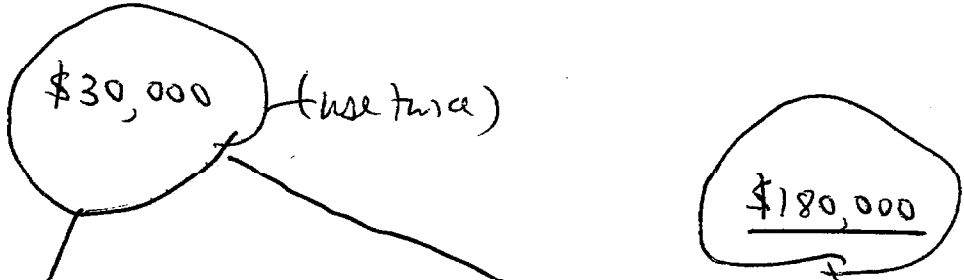
