#### TEMPORARY ASSISTANCE FOR NEEDY FAMILIES

Limitation on Administrative Salaries Charged to the W-2 Contracts

Motion:

CN5556

Move to limit the amount of any administrator's or subcontractor's cash compensation that can be charged to the W-2 agency contracts to the salary of the current Governor as specified in the biennial compensation plan for elected officials.

Note:

The Governor's salary is set in the biennial compensation plan for elected officials. There are two pay levels, one for incumbents and one for newly elected or appointed officials. The incumbent's rate of pay is frozen for four years, while the rate for newly elected or appointed officials is adjusted annually. The motion would limit the amount of any administrator's or subcontractor's cash compensation that could be charged to the W-2 contracts to the Governor's actual salary, whichever rate applies. The Governor's salary through June 30, 2001, is \$122,406.
