Bonuses Paid to W-2 Agency Staff and Subcontractors

LN5557

Motion:

Move to specify that any bonuses paid to W-2 agency staff and subcontractors' staff must be based on an individual's success in helping W-2 participants increase their household income over the federal poverty level. Require DWD to establish criteria against which an individual's performance must be measured in determining whether staff bonuses may be paid. Require the W-2 agencies to report quarterly to DWD on bonuses paid to agency staff and subcontractors' staff. Specify that this provision would be effective on January 1, 2002.

Note:

There are not any provisions under current law regarding bonuses paid to W-2 agency staff and staff of subcontractors. The motion would specify that bonuses paid to W-2 agency staff and staff of subcontractors must be tied to helping individuals increase their household income over the federal poverty level. DWD would be required to establish criteria for determining when staff bonuses may be paid. The motion would also require W-2 agencies to report quarterly to DWD on bonuses paid to administrative staff and subcontractors. These provisions would go into effect on January 1, 2002.


