Report on DVR client waiting lists, personnel and capacity to handle caseload

-- Require the Division of Vocational Rehabilitation within the Department of Workforce Development to issue a nine-month report on the elimination of prior client waiting lists, the status of personnel and the current and future capacity of DVR to handle client caseloads.

Require that the report be submitted to all standing committees and to the Joint Committee on Finance on or before the first day of the ninth month after the state budget has been signed into law.

Note: This is a new proposal, not included in either the Governor's Budget recommendations, any LFB paper, or free standing motion. The purpose of the amendment is to foster further discussions between the Department and the legislature on the elimination of client waiting lists, following the severe budget shortfalls in the Department that caused a temporary lapse in services, and the creation of those waiting lists.
