Currently, the Taycheedah Correctional Institution (TCI) for females has 9.5 teacher positions for 536 inmates; the John Burke Center (JBCC) has 2.0 teachers for 210 inmates; and the Robert Ellsworth Center (REECC) has 5.0 teachers for 283 inmates. The Fox Lake Correctional Institution for male offenders has 34.0 teachers for 1,227 inmates.

The motion provides \$476,900 GPR in 2001-02 and \$629,700 GPR in 2002-03 and 12.5 GPR teacher positions annually (5.5 teachers at the Taycheedah Correctional Institution, 4.0 teachers at the John Burke Correctional Center and 3.0 teachers at the Robert Ellsworth Correctional Center) to provide a teacher to inmate ratio at TCI, JBCC and REECC that is similar to that at Fox Lake.


