#### HILLSBORO CAMPING & RECREATION AREA

Move to require the Department of Natural Resources Stewardship 2000 program to approve a \$60,000 grant during the 2001-03 biennium to the City of Hillsboro for the creation of a camping and recreation area off of the Hillsboro & NorthEastern Spur Trail.

The Spur is a former railroad bed of 4.5 miles that connects to the "400" State Trail in Union Center and is part of the State Trails Network Plan. The City of Hillsboro is part of a coalition with Vernon County and Juneau County that has a memorandum of understanding with the State of Wisconsin regarding the trail.

The 7.5-acre parcel of land that would be purchased with this \$60,000 would well serve a future camping and recreational area, immediately off the trail, for the many users of the trail system for many years to come. This area will also help Hillsboro promote tourism for the area and address a lack of camping and recreation areas in the region.


