Hi John.

I have a couple of items I wanted to point out to you relating to MA drafts.

- 1. on LRB 0744/1 (Caucus #1107), I would recommend on page 1, line 6, deleting the phrase "and the reimbursement rates paid to disproportionate share hospitals for inpatient services." It is my understanding that this draft was intended to reverse Joint Finance action on this issue. However, Joint Finance action on this issue didn't affect reimbursement rates paid to disproportionate share hospitals and therefore, it is probably not appropriate to include this reference.
- 2. on LRB 1022/1 (Caucus #6557). I believe this motion is based on an estimate I prepared for Sen. George last March. The funding amount provided in my estimate included the effect that rate increases have on BadgerCare funding. As a result, if the intent of the motion is to provide funding based on my estimate, I would recommend that of the amount provided, \$1,051,200 be budgeted in the MA benefits appropriation and the remainder (\$15,000 GPR) be budgeted in the BadgerCare benefits appropriation.

If you agree with my suggestions, I would be happy to discuss them directly with LRB if you'd like, or if you would rather discuss them with LRB yourself, that would be fine too. Thanks.
