Move to repeal the provisions authorizing the expenditure of \$1.8 million in recreational boating project aids SEG (water resources account) and \$1.6 in general obligation bonding for the restoration and an endowment for the operation and maintenance of the Black Point Estate.

Note:

The Black Point Estate refers to a parcel of land in Walworth County that includes approximately 600 feet of frontage on the south shore of Lake Geneva and a 13-bedroom Queen Anne style residence constructed in 1888. The historic residence includes a significant collection of late-Victorian furniture. 1997 Act 27 authorized the bonding to adapt the estate to public use as a museum and the water resources SEG for an endowment to a nonprofit conservation organization for operation and preservation of the property. No expenditures have been made to date as various zoning and legal challenges to the project have been pursued. If the project is repealed \$1.8 million in water resources SEG would again be available for recreational boating project aids. Debt service on \$1.6 million in bonds, once issued, would be approximately \$130,000 GPR annually for 20 years.
