

The Veterans Trust Fund was created as a self-perpetuating vehicle to finance most of the loan and grant programs for state veterans. The use of trust fund resources to assist a private fund raising venture for the development of an education center at the Veterans War Memorial / Milwaukee, Inc. is inconsistent with the trust funds mission.

Analysis by the Legislative Reference Bureau VETERANS AND MILITARY AFFAIRS

Currently, Milwaukee County has the authority to establish and maintain a memorial to Wisconsin residents who have lost their lives in the military service. This bill authorizes DVA to provide, in the 2001–03 fiscal biennium, one grant of \$100,000 to the Wisconsin Veterans War Memorial/Milwaukee, Inc., for a veterans education center.

For further information see the **state** fiscal estimate, which will be printed as an appendix to this bill.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

- 2 Section 1. 20.485 (2) (vj) of the statutes is created to read:
- 3 20.485 (2) (vj) Education center grant. Biennially, the amounts in the schedule
- for a grant to the Wisconsin Veterans War Memorial/Milwaukee, Inc., under 2001
