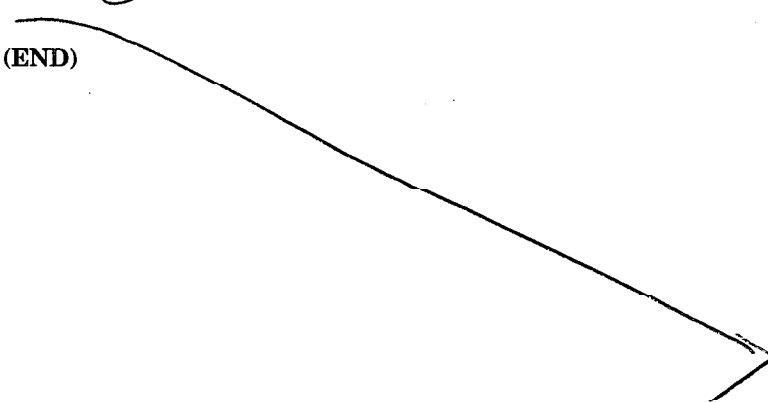

5 community center, if the property is used for moral, religious, and educational  
6 purposes and is not used for pecuniary profit of any individual.”.

7 **2.** Page 1404, line 8: after that line insert:

8 “(8q) **JEWISH COMMUNITY CENTERS.** The treatment of section 70.11 (12m) of the  
9 statutes first applies to the property tax assessments as of January 1, 2001.”.
