Summary

Under current law, members of authorized special groups may obtain special distinguishing plates for automobiles, motor homes and certain dual purpose motor homes, and farm trucks and dual purpose farm trucks that are owned or leased by members of authorized special groups. Authorized special groups include veterans of the U.S. army, navy, air force, coast guard, and marine corps. In addition to the regular annual registration fee, the department of transportation charges members of the authorized special groups a fee for the issuance or reissuance of a special plate. Veterans currently pay an additional annual fee of \$10 for a special plate, which is then deposited into the transportation fund.

The amendment would establish a special distinguishing registration plate for motorcycles that are owned or leased by veterans of the U.S. armed forces.

Fiscal Impact

According to the Legislative Fiscal Bureau, DOT estimates the cost of producing the plate at \$34,600. The cost of producing the plate can be funded from a portion of the existing balance in the Transportation Fund.


