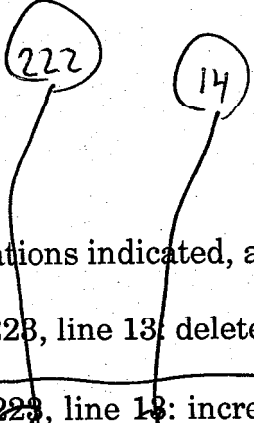

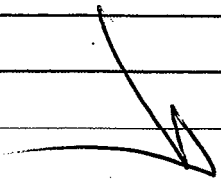

Adding the \$400,000 to s. 49.175 (1) (q) would work even though the current figures consist entirely of FED moneys and the \$400,000 is GPR. This approach would work because s. 49.175 (1) (intro.) cites both GPR and FED moneys, and none of the allocation paragraphs under s. 49.175 distinguish between GPR, FED, and PR.
