Producer Security Fund (Governor's Summary, page 104, item #17)

This was originally introduced by the Governor but was removed as a policy item by the co-chairs of Joint Finance. This provision consolidates the current vegetable processor, dairy plant operator, and grain dealer and warehouse keeper programs. Further, convert security requirements to the consolidated program to an insurance pool funded by industry assessments.

In addition to the Governor's language, these assessments would be put into a separate non-lapsible trust fund designated as the agricultural producer security fund, to consist of all fees, surcharges, assessments, reimbursements, and proceeds of surety bonds received by the Department of Agriculture, Trade and Consumer Protection.

Also, the agricultural producer security fund is a public trust established to secure payments to agricultural producers. Moneys deposited to the fund shall not be used for any other purpose.

Fiscal Impact: No GPR. However, there is a fiscal impact to each group depending on what type of dealer and the difference between their current, individual security plan. Varying impact on each.

Drainage District (requested by Ainsworth) (Governor's Summary, pg. 94, item #9)

This item, proposed by the Governor was removed as a policy item by the cochairs of Joint Finance. This would restore the Governor's position.

In addition, (requested by Albers) require counties to submit any preliminary GIS maps they produce that include streams, ditches, dikes or levees to the drainage district with land in that county. Within 120 days, the drainage district must send notice to the county of any needed changes due to errors or omission. If the county does not concur with the drainage district's changes and make the changes, require the Land Information Council in DOA to mediate the dispute between the county and the drainage district, objectively resolving the conflict.

Also modify language in 2001 Wisconsin Act 6 (wetlands bill) (requested by Ainsworth) to remove the Department of Natural Resources new regulatory authority to write "best management practices" and administrative rules regulating farm roads and forest roads.

Under current law, the Department of Agriculture, Trade and Consumer Protection provides financial assistance to owners of livestock herds for conducting testing for paratuberculosis (commonly called Johne's disease.)

Return to Governor's position. Restore \$3 million GPR in 2002-03 for grants to ethanol producers. Further, transfer the program from the Department's marketing division to its trade and consumer protection division. 1999 Act 55 created an ethanol producer grant program for annual payment of 20 cents per gallon to qualifying producers for up to 15 million gallons (\$3 million per producer maximum) of ethanol produced in a 12-month period. No funding was provided under Act 55. If appropriated funds are insufficient to pay all ethanol producer claims, payments are prorated.

Fiscal Impact: Appropriate \$3,000,000 in fiscal year 2002-03 from the oil overcharge account in the Department of Administration to administer the program.

√7. Integrated Pest Management (IPM) (Comparative Summary, pg. 136, item 14) (requested by Hahn, motion reguest #18)

> Delete Joint Finance action. Return to Governor's position to provide \$118,200 in 2001-02 and \$121,200 in 2002-03 and 1.0 position from the agrichemical management fund to convert and expiring IPM specialist project position to permanent and provide additional contract funding to expand DATCP'S IPM assistance program in K-12 schools. The program assists public and private school staff in the use of IPM.

> Fiscal Impact: Provide \$118,200 in 2001-02 and \$121,200 in 2002-03 and 1.0 position from the agrichemical management fund. Saves \$316,400 and 2.0 SEG positions over the biennium.
