29. Dental School Staff Licensing:

An applicant who is invited to serve on the academic staff of a dental school in this state as a member of the faculty shall be granted a faculty license if the applicant does not engage in any of the types of conduct prohibited by ss. 447.07(3)(a)-(o). → grounds for discipline

Such license shall remain in force only while the holder is serving full-time on the academic staff of a dental school. The holder's license allows practice within educational facilities and as adjunct to teaching functions. Such license shall expire 2 years after its date of granting and may be renewed at the discretion of the Dental Examining Board (DEB). The board may require an applicant for licensure under this subdivision to appear for an interview.

The board may promulgate rules to carry out the purposes of this subdivision. This reflects an agreement between DEB and Marquette Dental School.

30. Drug and Alcohol Regulation and Licensing:

Require certification for Alcohol and Drug Counselors to Regulation and Licensing, and grant rule-making authority. This will ensure we have counselors who are certified.

The amendment creates a \$53 renewal fee for visiting faculty members, which is the base renewal fee for new licenses that are created in this biennium. Alternatively, you could require the visiting faculty members to pay the same renewal fee as other dentists (which is \$131). However, I thought that ~~DRL's~~ regulatory expenses would be ~~less~~ less for visiting faculty members, so I created a different renewal fee for them. Is that okay?

Also note that Assembly Bill 367 contains provisions that are similar, but not identical, to this amendment. It doesn't appear that you want an amendment that is identical to Assembly Bill 367, but I thought you might be interested in how that bill differs from this amendment.

Mark,

Thanks for getting back to me on this. This GREATLY helped to clarify things not only for me, but for the rest of those involved in this language.

Here are two thoughts that I have derived over the discussions with our dental negotiating group:

1. On page two of your draft, lines 1,2,&3: Our group would feel more comfortable (even though you say that due to existing statutes this language is probably not necessary) if the verbiage on the calling on the **Board to promulgate rules to carry out the purposes of this subdivision** was included. They want it absolutely clear the Board to be given the authority so that they can do this. (Their legal counsel would like it added just to be certain.)
2. On page one of your draft, line five, the dollar amount should be increased to reflect what licenses cost to **\$83**. Also, please **delete the word "visiting"** from line 4.

Let me know your thoughts on this. When you have the chance to finalize things if you could send me via email an updated draft so I can re-send to them I would greatly appreciate it.

Comparison of language provided and LRBb1503/1:

The language provided refers to an applicant "invited to serve on academic staff of dental school as a member of the faculty".

LRBb1503/1 requires applicant to submit proof satisfactory to examining board that he or she has been offered employment as full-time faculty member at school of dentistry in this state. I changed the language because the meaning of "invited to serve" is not as clear as an offer of employment.

The language provided says that an applicant may be granted a license if he or she hasn't engaged in conduct prohibited in s. 4447.07 (2) (a) to (o).

LRBb1503/1 accomplishes the same thing because, when the examining board grants any type of license, including the faculty license created in the amendment, the board can deny the license if a person has engaged in the conduct prohibited in s. 447.07 (2) (a) to (o).

The language provided says that a license remains in force while the holder is serving full-time on the academic staff of a dental school.

LRBb1503/1 accomplishes the same thing by providing that the license is no longer in effect if the holder ceases to be employed as a full-time faculty member at a school of dentistry in this state.

The language provided says that the license allows practice within educational facilities and as an adjunct to teaching functions.

LRBb1503/1 accomplishes the same thing with different language, by providing that a license authorizes the holder to practice only within educational facilities and only for the purpose of carrying out teaching duties. The phrase "as an adjunct to teaching functions" didn't seem clear because I didn't think "adjunct" was properly used in its everyday dictionary meaning.

The language provided says the license expires 2 years after the date that it is granted and may be renewed at the discretion of the board.

Under LRBb1503/1, a license holder must renew the license by Oct. 1 of every odd year. This approach is consistent with renewal of other professional licenses. Also, we don't make renewal conditional at the discretion of a licensing authority.

The language provided says that the board may require an applicant to appear for an interview.

LRBb1503/1 allows the board to require an interview, but also provides a reason for the interview, by allowing the board to deny a license if an applicant makes responses that demonstrate that the applicant is not competent to practice dentistry. I think you can't simply require an interview unless you say what the purpose of it is.

The language provided allows the board to promulgate rules.

This isn't included in LRBb1503/1 because it isn't necessary. The board already has authority under s. 15.08 (5) (b), stats., to promulgate rules for its own guidance or the guidance of the regulated profession, which would include visiting faculty members.

I hope the above info is helpful.
