

Summary Designate \$250,000 to the Domestic Abuse Program. An increase in funding is necessary for local domestic violence programs to offer salary and benefits that are comparable to and competitive with other local employers. These programs have been strongly impacted by the labor shortage.

The funds are to be distributed by increasing each of the following Domestic Abuse Program grant awards by 6.3%:

- 1) Basic Services
- 2) Children's Programming 1.
- 3) Expansion/Satellite Programs 7.
- 4) Tribal Programs
- 5) Under-represented Populations 8.
- 6) Training/Technical Assistance -6.
