Statement of Intent This motion deletes two provisions relating to the Prevailing Wage that were approved in the JFC and reverts back to current law. The two provisions are Item 20 (Prevailing Wage Rate--Annual Wage Rate Survey) and Item 21 (Prevailing Wage Rate--Contractor Records) in the Workforce Development-Employment, Training and Vocational Rehabilitation portion of the Comparative Summary of Budget Recommendations, as prepared by the Legislative Fiscal Bureau.

Summary This motion would delete:

*Annual Wage Rate Survey---which would allow the reporting of wages paid for public works projects on the annual wage rate survey used to determine prevailing wages when the wage rate paid on a public works project is more than the prevailing wage rates established for the project.

*Contractor Records--which would require all contractors and subcontractors that work on a project subject to the provisions of the state prevailing wage laws to maintain payroll records of covered employees and to allow the public to inspect these records except for the information that could be used to identify individual employees under the state public records law.

The motion reverts back to current law for the calculation of prevailing wage rates for state and local public projects and to determine authorized agencies to examine payroll records.
