Campaign Finance Reform Package

- Make the Wisconsin election campaign a true fund taxpayer check-off (Walker)
- In order to qualify for campaign finance grant, a candidate for legislative office must raise at least 50 percent of his or her qualifying contributions from individuals who are residents of a county having territory within the district in which the candidate seeks office. Remaining 59% from WI.
- Campaign finance contributions registrations for individuals who do not maintain an office or street address in the state must be reported in the same manner as individuals with an in state address
- Establish that referendum by local governments can be held at the spring primary, the spring election or the first Tuesday after the first Monday in November of an odd-numbered year or general election of each even-number year.
- Establish that qualifying candidates for Justice of the Supreme Court will have their grants from the Wisconsin election campaign fund fully funded.

Only the first \$100 of an aggregate contribution of more than \$100 may be counted toward the required percentage. For a candidate at the spring or general election for an office identified in s. 11.26 (1) (a) or a candidate at a special election, the required amount to qualify for a grant is 5% of the candidate's authorized disbursement limitation under s. 11.31. For any other candidate at the general election, the required amount to qualify for a grant is 10% of the candidate's authorized disbursement limitation under s. 11.31.".

Only the first \$100 of an aggregate contribution of more than \$100 may be counted toward the required percentage. For a candidate at the spring or general election for an office identified in s. 11.26 (1) (a) or a candidate at a special election, the required amount to qualify for a grant is 5% of the candidate's authorized disbursement limitation under s. 11.31. For any other candidate at the general election, the required amount to qualify for a grant is 10% of the candidate's authorized disbursement limitation under s. 11.31.".
