Eliminate the funding for the reintroduction of the Whooping Crane

Affected agency: DNR

Fiscal Impact: Cut \$81,100 SEG

Delete \$880,400 GPR in funding for the Water Integration Team.

Fiscal Impact: Reduce \$880,400 from GPR over the biennium and 6.5 positions

**O. Coaster Trout Reintroduction Program**

This motion would eliminate the \$170,000 PR allocation of tribal gaming funds to the DNR for the coaster trout reintroduction program. The budget currently provides \$20,000 PR in '01-'02 and \$150,000 PR in '02-'03 from tribal gaming revenues.

Affected agency: DNR

Fiscal Impact: Cut \$170,000 PR over the biennium generated from tribal gaming revenue.

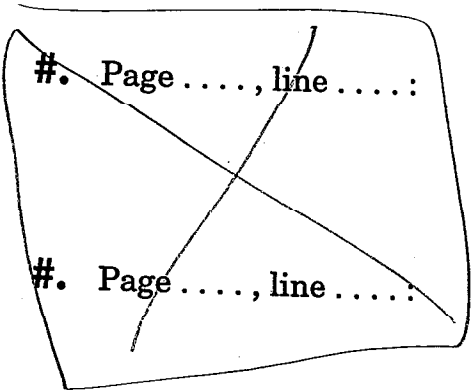
