6. Air Management

A. Bureau of Air Management — General Construction Permits

Authorize DNR to promulgate administrative rules that specify the types of stationary sources of air emissions that may obtain general construction permits. A general construction permit may cover several similar stationary sources. It would be used instead of issuing an individual construction permit for each source covered by the general construction permit. Examples of categories for which a general construction permit might be created would include crushers, package boilers, degreasing units, dry cleaners and hot-mix asphalt plants.

TO ASSEMBLY SUBSTITUTE AMENDMENT 1,

TO 2001 SENATE BILL 55

At the locations indicated, amend the substitute amendment as follows:

1. Page 467, line 2: after that line insert:

“6. The board notifies the joint committee on finance in writing of its intention to purchase the land. If the cochairpersons of the committee do not notify the board that the committee has scheduled a meeting for the purpose of reviewing the proposed purchase of land within 14 working days after the date of the board’s notification, the land may be purchased by the board. If, within 14 working days after the date of the board’s notification, the cochairpersons of the committee notify the board that the committee has scheduled a meeting for the purpose of reviewing

the proposed purchase, the land may be purchased only upon approval of the committee.”.
