2001 ASSEMBLY BILL 125

February 15, 2001 - Introduced by Representatives OWENS, McCORMICK, AINSWORTH, ALBERS, GUNDERSON, HUNDERTMARK, KRAWCZYK, LADWIG, LASSA, MUSSER, OTT, SERATTI, URBAN and VRAKAS, cosponsored by Senators WELCH and LAZICH. Referred to Committee on Family Law.

1 AN ACT to amend 118.019 (2) (intro.) and 118.019 (2) (e); and to create 118.019
2 (2m) of the statutes; relating to: requiring school boards that provide
3 instruction in human sexuality and related subjects to provide instruction in
4 marriage and parental responsibility.

Analysis by the Legislative Reference Bureau

Current law permits a school board to provide instruction in human sexuality, reproduction, family planning, human immunodeficiency virus and acquired immunodeficiency syndrome, prenatal development, childbirth, adoption, available prenatal and postnatal support, and male responsibility. This bill allows a school board to provide instruction in both male and female responsibility. The bill also provides that if a school board offers instruction in any of these subjects relating to human sexuality, it must also offer instruction in marriage and parental responsibility.
