Summary

Under current law, digital broadcasting equipment owned and used by a radio station or a television station is exempt from general property taxes. This motion would make the exemption uniform, extending the general property tax exemption to digital broadcasting equipment that is owned and used by a cable television system.

Fiscal Impact

The motion would exempt an estimated \$3.3 million in value from the property tax base on a statewide basis, reducing property taxes by an estimated \$86,000 statewide.




