Summary

Under current law, the sale of trucks to those who haul property for hire is exempt. The Department of Revenue (DOR), however, interprets "property" to mean something of value and, therefore, trucks that haul "valueless" property, such as refuse, are not eligible for the sales tax exemption.

The amendment specifies that the sales tax exemption apply to trucks that haul property for hire without value such as waste material, snow, refuse or garbage. The sales tax exemption does not apply to those who are not in the trucking business.
