7 “SECTION 2850d. 146.65 of the statutes is created to read:

8 **146.65 Rural health dental clinic.** From the appropriation under s. 20.435  
9 (5) (dm), the department shall distribute funds to the rural health dental clinic  
10 located in Ladysmith that provides dental services to persons in the counties of Rusk,  
11 Price, Taylor, Sawyer, and Chippewa who are developmentally disabled or elderly or

1       who have low income. The department shall also seek federal funding to support the  
2       operations of the rural health dental clinic.”.
