1 At the locations indicated, amend the substitute amendment as follows:

2 1. Page 24, line 21: after that line insert:

3 "SECTION 130q. 15.05 (1) (b) of the statutes is amended to read:

4 15.05 (1) (b) Except as provided in ~~para. (c) and par.~~ (d), if a department is under  
5 the direction and supervision of a board, the board shall appoint a secretary to serve  
6 at the pleasure of the board outside the classified service. In such departments, the  
7 powers and duties of the board shall be regulatory, advisory, and policy-making, and  
8 not administrative. All of the administrative powers and duties of the department  
9 are vested in the secretary, to be administered by him or her under the direction of  
10 the board. The secretary, with the approval of the board, shall promulgate rules for

1 administering the department and performing the duties assigned to the  
2 department.

3 **SECTION 130r.** 15.05 (1) (c) of the statutes is repealed.”
