1 AN ACT *to create* 77.54 (44) of the statutes; **relating to:** exempting sales of
2 United States flags and state flags from the sales tax and the use tax.

Analysis by the Legislative Reference Bureau

This bill creates a sales and use tax exemption for the United States flag and the state flag.
