1. Page 138, line 2: after that line insert:

“(kn) Federal funds transferred from  
the department of workforce  
development; after-school care  
grant program

PR-S C -0- -0-”.

2. Page 318, line 8: after that line insert:

“SECTION 560d. 20.255 (2) (kn) of the statutes is created to read:

20.255 (2) (kn) *Federal funds transferred from the department of workforce  
development; after-school care grant program.* All moneys transferred from the

1 appropriation account under s. 20.445 (3) (md) for after-school care grants under  
 2 2001 Wisconsin Act .... (this act), section 9140 (6<sup>d</sup>~~w~~). No moneys may be encumbered  
 3 under this paragraph after June 30, 2003.”.

4 **3.** Page 374, line 1: delete lines 1 to <sup>9</sup>~~3~~ and substitute:

5 “SECTION 743<sup>d</sup>~~c~~. 20.445 (3) (md) of the statutes is amended to read:

6 20.445 (3) (md) *Federal block grant aids*. The amounts in the schedule, less

 11 All block grant moneys received for these purposes from the federal government or

(a) A school board may apply to the state superintendent of public instruction for a grant to fund an after-school care program for pupils who are eligible to receive temporary assistance for needy families under 42 USC 601 to 619 and who would otherwise be unsupervised by an adult in the afternoon after school.

(b) The state superintendent of public instruction shall award grants from the appropriation under section 20.255 (2) (kn) <sup>✓</sup> of the statutes, as created by this act, and shall ensure, to the extent feasible, that the grants are evenly distributed among rural, suburban, and urban school districts.”.
