- 1 At the locations indicated, amend the substitute amendment as follows:
- 2 **1.** Page 238, line 17: increase the dollar amount for fiscal year 2001-02 by
- 3 \$3,000 to increase funding for providing flags to the Wisconsin Veterans Tribute
- 4 Memorial.
- 5 **2.** Page 382, line 3: after that line insert:
- 6 “SECTION 785e. 20.485 (2) (e) of the statutes is amended to read:
- 7 20.485 (2) (e) *Veterans memorial grants.* From the general fund, as a
- 8 continuing appropriation, the amounts in the schedule for the veterans memorial
- 9 grant program under s. 45.04 and for the grant under 2001 Wisconsin Act ... (this
- 10 act), section 9157 (8g).”.

1 **3.** Page 1368, line 4: after that line insert:

2 “(8g) GRANT TO WISCONSIN VETERANS TRIBUTE MEMORIAL. In fiscal year 2001–02,
3 the department shall provide a grant from the appropriation account under section
4 20.485 (2) (e) of the statutes, as affected by this act, in the amount of \$3,000 to the
5 Wisconsin Veterans Tribute Memorial in Chippewa County for the repair and
6 replacement of flags at the memorial if the Wisconsin Veterans Tribute Memorial
7 provides matching funds of \$3,000.”.
