Rep. Krug has asked me to request a draft of LRB 2145--expanding the Prevention of Child Abuse and Neglect (POCAN) program-as a budget amendment...an AA to ASA 1 to SB 55.

Here's the request...

Proposed drafting request:

Expand the Prevention of Child Abuse and Neglect (POCAN) grant program administered by DHFS to an additional 14 rural counties, six urban counties and four tribes, beginning in 2001-02. (See LRB 2145/1 GMM).

According to a June 12, 2001 LFB memo, it is estimated that the cost of the POCAN expansion would be \$2,178,300 annually.

Funding for the POCAN expansion would be paid for this way:

- For POCAN grants to all additional counties and tribes, reallocate \$2,178,300 annually from state administration funding for TANF.
- If Milwaukee county applies and is granted POCAN funding, fund the Milwaukee county expansion from the \$1.98 million in unexpended Community Reinvestment funds that results from the termination of the Employment Solutions, Inc. (ESI) W-2 contract.

According to a June 7, 2001 memorandum of understanding between DWD and ESI, DWD will assume control of ESI's unexpended community reinvestment funds and is directed to spend them in Milwaukee County for TANF purposes.

Direct DWD to reserve up to ~~\$XXXXXX~~ (this number will be forthcoming) of ESI's unspent community reinvestment funds to fund the POCAN expansion in Milwaukee County. (Note: According to LFB, the average amount of an urban county POCAN grant is \$188,000.)

If Milwaukee County gets a POCAN grant, the amount of the grant will be subtracted from the overall allocation for the POCAN expansion (from TANF state administration) and returned to the state TANF contingency fund.

***Analysis by the Legislative Reference Bureau***

Under current law, the department of health and family services (DHFS) administers a child abuse and neglect prevention program under which DHFS awards grants to counties and Indian tribes that offer home visitation services to first-time parents who are eligible for medical assistance and that offer services to families that have been the subject of a child abuse or neglect report, or that have requested services to prevent child abuse or neglect, and that are at substantial risk of future child abuse or neglect, are willing to cooperate with an informal plan of support and services, and are not likely to be the subject of a formal child in need of protection or services proceeding. Currently, no more than six rural counties, three urban counties, and two Indian tribes may be selected to participate in the program. This bill authorizes no more than 20 rural counties, nine urban counties, and five Indian tribes to participate in the program and provides additional funding for that program expansion.



