**Senate:** No change to Joint Finance.

**Assembly:** Delete a provision of the Joint Committee on Finance's substitute amendment that would require DOT to allocate \$200,000 from the SEG appropriation for local transportation facility improvement assistance during the 2001-03 biennium to extend Port Arthur Road in the City of Ladysmith, if the City provides a local contribution toward the costs of the project equal to at least 20% of the cost of the project.

**20. LOCAL ROADS IMPROVEMENT PROJECT ALLOCATION FOR 85<sup>TH</sup> STREET IN THE VILLAGE OF PLEASANT PRAIRIE**

**Senate:** Require DOT to make a grant of \$609,000 in the 2001-03 biennium to the Village of Pleasant Prairie in Kenosha County from funds appropriated for the local roads improvement program for improvements to 85<sup>th</sup> Street in the Village. Specify that the grant shall be made before making any allocation of funds under the basic allocation component of the program and shall not affect the entitlement received by the Village under that component. Specify that the grant shall be made notwithstanding the limitations on the amount and use of aids or on the eligibility requirements for receiving aids under the program.

**Assembly:** No change to Joint Finance.

**21. LOCAL ROADS IMPROVEMENT PROJECT ALLOCATION FOR 80<sup>TH</sup> STREET IN THE VILLAGE OF PLEASANT PRAIRIE**

**Senate:** Require DOT to make a grant of \$637,000 in the 2001-03 biennium to the Village of Pleasant Prairie in Kenosha County from funds appropriated for the local roads improvement program for construction of 80<sup>th</sup> Street between Cooper Road and 57<sup>th</sup> Avenue in the Village. Specify that the grant shall be made before making any allocation of funds under the basic allocation component of the program and shall not affect the entitlement received by the Village under that component. Specify that the grant shall be made notwithstanding the limitations on the amount and use of aids or on the eligibility requirements for receiving aids under the program.

**Assembly:** No change to Joint Finance.
