1 At the locations indicated, amend the substitute amendment as follows:

5 2. Page 364, line 20: after "250.15" insert "and 2001 Wisconsin Act (this act),

7 3. Page 1338, line 20: after that line insert:
8 "(14e) MILWAUKEE HEALTH CLINICS GRANTS. In fiscal year 2001-02, from the
9 appropriation account under section 20.435 (5) (fh) of the statutes, as affected by this
10 act, the department of health and family services shall provide all of the following:

(a) One grant in the amount of ~~\$1,000,000~~^{273,300} to the Milwaukee Immediate Care Center to allow continued operation of the facility.
