In addition to the provisions identified above, the substitute ammendment would authorize DHFS to distribute substance abuse services grants to all counties, rather than Milwaukee County, exclusively, effective January 1, 2002. Under current law, DHFS distributes a \$5,000,000 GPR annual grant to Milwaukee County that the county uses to provide substance abuse services to TANF-eligible indivudals with family incomes equal to or less than 200% of the federal poverty level. Funding for these grants is counted toward the state's TANF maintenance of effort requirement.
