This bill increases the authorized program revenue supported borrowing authority of the state by \$42,600,000 for the 1999–2001 fiscal biennium for the purpose of purchasing a Justice Center building.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

- **SECTION 1.** 20.866 (2) (y) of the statutes is amended to read:

- 5 From the capital improvement fund, a sum sufficient to the building commission for
- 6 the purpose of housing state departments and agencies. The state may contract
