

2001 ASSEMBLY BILL 513

1 **AN ACT relating to:** repealing, consolidating, renumbering, amending and
2 revising various provisions of the statutes for the purpose of correcting errors,
3 supplying omissions, correcting and clarifying references, eliminating defects,
4 anachronisms, conflicts, ambiguities and obsolete provisions, reconciling
5 conflicts, and repelling unintended repeals (Revisor's Correction Bill).

Analysis by the Legislative Reference Bureau

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

6 **SECTION 1.** 1.13 (3) of the statutes is amended to read:
7 1.13 **(3)** Consistently with other laws, each state agency, whenever it
8 administers a law under which a local governmental unit prepares a plan, is
9 encouraged to design its planning requirements in a manner that makes it practical
10 for local governmental units to incorporate these plans into local comprehensive
11 plans prepared under s. ~~66.0295~~ 66.1001.

1 **SECTION 2.** 16.957 (1) (w) of the statutes is amended to read:

3 a municipal electric company, as defined in s. ~~66.073~~ 66.0825 (3) (d), that supplies
4 electricity at wholesale to a municipal utility or retail electric cooperative.

5 **SECTION 3.** 16.965 (2) of the statutes is amended to read:

6 16.965 **(2)** From the appropriation under s. 20.505 (1) (cm), the department
7 may provide grants to local governmental units to be used to finance the cost of
8 planning activities, including contracting for planning consultant services, public
9 planning sessions, and other planning outreach and educational activities, or for the
10 purchase of computerized planning data, planning software, or the hardware
11 required to utilize that data or software. The department shall require any local
12 governmental unit that receives a grant under this section to finance a percentage
13 of the cost of the product or service to be funded by the grant from the resources of
14 the local governmental unit. The department shall determine the percentage of the
15 cost to be funded by a local governmental unit based on the number of applications
16 for grants and the availability of funding to finance grants for the fiscal year in which
17 grants are to be provided. A local governmental unit that desires to receive a grant
18 under this subsection shall file an application with the department. The application
19 shall contain a complete statement of the expenditures proposed to be made for the
20 purposes of the grant. No local governmental unit is eligible to receive a grant under
21 this subsection unless the local governmental unit agrees to utilize the grant to
22 finance planning for all of the purposes specified in s. ~~66.0295~~ 66.1001 (2).

1 **SECTION 4.** 16.9651 (2) of the statutes is amended to read:

2 16.9651 (2) From the appropriation under s. 20.505 (1) (z), the department may
3 provide grants to local governmental units to be used to finance the cost of planning
4 activities related to the transportation element, as described in s. ~~66.0295~~ 66.1001
5 (2) (c), of a comprehensive plan, as defined in s. ~~66.0295~~ 66.1001 (1) (a), including
6 contracting for planning consultant services, public planning sessions, and other
7 planning outreach and educational activities, or for the purchase of computerized
8 planning data, planning software, or the hardware required to utilize that data or
9 software. The department may require any local governmental unit that receives a
10 grant under this section to finance not more than 25% of the cost of the product or
11 service to be funded by the grant from the resources of the local governmental unit.
12 Prior to awarding a grant under this section, the department shall forward a detailed
13 statement of the proposed expenditures to be made under the grant to the secretary
14 of transportation and obtain his or her written approval of the proposed
15 expenditures.

19 general program operations of the office of the commissioner of railroads. Ninety
20 percent of all moneys received by the office under s. 195.60 or ~~200.10~~ 201.10 (3) shall
21 be credited to this appropriation.

3 appropriation under s. 20.866 (2) (ta) without the prior approval of a majority of the
4 members–elect, as defined in s. 59.001 (2m), of the county board of supervisors of the
5 county in which the land is located if at least 66% of the land in the county is owned
6 or under the jurisdiction of the state, the federal government, or a local governmental
7 unit, as defined in s. ~~66.299~~ 66.0131 (1) (a). Before determining whether to approve
8 the acquisition, the county in which the land is located shall post notices that inform
9 the residents of the community surrounding the land of the possible acquisitions.

10 **SECTION 7.** The treatment of 29.924 (4) of the statutes by 1997 Wisconsin Act

12 150, section 2. All treatments stand.

warehouse or building used for the storage or retention of wild animals or carcasses shall
permit the department and its wardens to enter and examine the premises subject to s.
66.0119. The owner or occupant, or the agent or employee of the owner or occupant, shall
deliver to the officer any wild animal or carcass, in his or her possession during the closed
season, whether taken within or without the state.

13 **SECTION 8.** 33.32 (5) of the statutes is amended to read:

14 33.32 **(5)** Sewerage system service charges imposed by districts with town
15 sanitary district powers shall be in conformance with s. 66.0821. Special charges for
16 other services identified in the annual budget adopted under s. 33.30 (3) (b) shall also
17 be collected directly by the commissioners. The commissioners shall allocate the
18 charges to the property served in a manner prescribed by them unless the manner

1 is specified by a resolution of the annual or of a special meeting. Delinquent special
2 charges shall be governed by s. ~~66.60 (16) (b)~~ 66.0627 (4).

5 depositor shall, by resolution, designate one or more public depositories, organized

7 state, in which the treasurer of the governing board shall deposit all public moneys
8 received by him or her and specify whether the moneys shall be maintained in time
9 deposits subject to the limitations of s. 66.0603 ~~(1)~~ (1m), demand deposits, or savings
10 deposits and whether a surety bond or other security shall be required to be
11 furnished under s. 34.07 by the public depository to secure the repayment of such
12 deposits. A designation of a public depository by the governing board shall be a
13 designation of the public depository for all treasurers of the governing board and for
14 all public depositors for which each treasurer shall act.

19 purposes of computing its legal debt limit, be deemed reduced by the amount of such
20 deposit. The city or village may invest these debt service fund moneys under s.
21 66.0603 ~~(1)~~ (1m) or 67.11 (2) and (3). Bonds and notes issued by districts for purposes
22 of this subsection shall not be subject to referendum. The purchase agreement shall

1 include an irrevocable clause providing that the district shall pay annually to the city

12 issued under this paragraph. Such notes shall mature and be payable at such times,
13 in such amounts and at such rate of interest as will amortize and pay when due the
14 principal and interest on the outstanding obligations of the city or village for
15 technical college purposes. All such notes, upon execution and delivery to the city
16 or village, shall in all respects be held and considered as an authorized investment
17 under s. 66.0603 (4) (1m) or 67.11 (2) and (3) of the debt service fund created for
18 payment of the city or village obligations issued for technical college purposes and
19 shall be offset against city or village indebtedness in computing legal debt limit to
20 the same extent as other authorized investments of the debt service fund and such
21 notes may be sold and hypothecated. If the offset against city or village indebtedness
22 under this paragraph is determined to be invalid in any respect, such city or village

1 immediately may require the district issuing the promissory notes to such city or
2 village to comply with pars. (c) and (d) to the extent necessary to cure such invalidity.

9 **SECTION 13.** 46.2895 (6) (f) of the statutes is amended to read:

11 officers, employees, and agents, insurance against any loss in connection with its
12 property and other assets and other necessary insurance; establish and administer
13 a plan of self-insurance; or, subject to an agreement under s. ~~66.30~~ 66.0301,
14 participate in a governmental plan of insurance or self-insurance.

intergovernmental cooperation, generally, were renumbered to s. 66.0301 by 1999 Wis.

15 **SECTION 14.** 59.69 (3) (a) of the statutes is amended to read:

16 59.69 (3) (a) The county zoning agency may direct the preparation of a county
17 development plan or parts thereof of the plan for the physical development of the
18 unincorporated territory within the county and areas within incorporated
19 jurisdictions whose governing bodies by resolution agree to having their areas
20 included in the county's development plan. The plan may be adopted in whole or in

1 part and may be amended by the board and endorsed by the governing bodies of
2 incorporated jurisdictions included in the plan. The county development plan, in
3 whole or in part, in its original form or as amended, is hereafter referred to as the
4 development plan. Beginning on January 1, 2010, if the county engages in any
5 program or action described in s. ~~66.0295~~ 66.1001 (3), the development plan shall
6 contain at least all of the elements specified in s. ~~66.0295~~ 66.1001 (2).

7 **SECTION 15.** 60.79 (2) (c) of the statutes is amended to read:

15 areas outside of its boundaries which that in the commission's judgment bear
16 relation to the development of the city provided, however, that in any county where
17 a regional planning department has been established, areas outside the boundaries
18 of a city may not be included in the master plan without the consent of the county
19 board of supervisors. The master plan, with the accompanying maps, plats, charts,
20 and descriptive and explanatory matter, shall show the commission's
21 recommendations for such physical development, and shall, as described in sub. (3)
22 (b), contain at least the elements described in s. ~~66.0295~~ 66.1001 (2). The commission

1 may from time to time amend, extend, or add to the master plan or carry any part
2 or subject matter into greater detail. The commission may adopt rules for the
3 transaction of business and shall keep a record of its resolutions, transactions,
4 findings, and determinations, which record shall be a public record.

5 **SECTION 17.** 62.23 (3) (b) of the statutes is amended to read:

6 62.23 (3) (b) The commission may adopt the master plan as a whole by a single
7 resolution, or, as the work of making the whole master plan progresses, may from
8 time to time by resolution adopt a part or parts of a master plan. Beginning on
9 January 1, 2010, if the city engages in any program or action described in s. ~~66.0295~~
10 66.1001 (3), the master plan shall contain at least all of the elements specified in s.
11 ~~66.0295~~ 66.1001 (2). The adoption of the plan or any part, amendment, or addition,
12 shall be by resolution carried by the affirmative votes of not less than a majority of
13 all the members of the city plan commission. The resolution shall refer expressly to
14 the elements under s. ~~66.0295~~ 66.1001 and other matters intended by the
15 commission to form the whole or any part of the plan, and the action taken shall be
16 recorded on the adopted plan or part thereof of the plan by the identifying signature
17 of the secretary of the commission, and a copy of the plan or part thereof of the plan
18 shall be certified to the common council. The purpose and effect of the adoption and
19 certifying of the master plan or part thereof of the plan shall be solely to aid the city
20 plan commission and the council in the performance of their duties.

3 district, drainage district, and, without limitation because of enumeration, any other

If the notice indicates that the petition is for a referendum on the question of annexation, the town clerk shall give notice as provided in par. (c) of a referendum of the electors residing in the area proposed for annexation to be held not less than 42 days nor more than 72 days after the date of personal service or mailing of the notice required under this paragraph. If the notice indicates that the petition is for direct annexation, no referendum shall be held unless within 30 days after the date of personal service or mailing of the notice required under this paragraph, a petition conforming to the requirements of s. 8.40 requesting a referendum is filed with the town clerk as provided in s. 8.37, signed by at least 20% of the electors residing in the area proposed to be annexed. If a petition requesting a referendum is filed, the clerk shall give notice as provided in par. (c) of a referendum of the electors residing in the area proposed for annexation to be held not less than 42 days nor more than 72 days after the receipt of the petition and shall mail a copy of the notice to the clerk of the city or village to which the annexation is proposed. The referendum shall be held at a convenient place within the town to be specified in the notice.

8 **SECTION 20.** The treatment of 66.0219 (4) (a) and (b) of the statutes by 1999
9 Wisconsin Act 150, section 68, is not repealed by 1999 Wisconsin Act 182, section 200.
10 Both treatments stand.

NOTE: There is no conflict of substance. As merged by the Revisor, s. 66.0219 (4)
(a) and (b) read:

(a) If the court, after the hearing, is satisfied that the description of the territory or any survey is accurate and that the provisions of this section have been complied with, it shall make an order so declaring and shall direct a referendum election within the territory described in the order, on the question of whether the area should be annexed. Such order shall be filed as provided in s. 8.37. The order shall direct 3 electors named in the order residing in the town in which the territory proposed to be annexed lies, to perform the duties of inspectors of election.

(b) The referendum election shall be held not less than 42 days nor more than 72 days after the filing of the order as provided in s. 8.37, in the territory proposed for annexation, by the electors of that territory as provided in s. 66.0217 (7), so far as applicable. The ballots shall contain the words “For Annexation” and “Against Annexation”. The certification of the election inspectors shall be filed with the clerk of the court, and the clerk of any municipality involved, but need not be filed or recorded with the register of deeds.

1 **SECTION 21.** The treatment of 66.0225 of the statutes by 1999 Wisconsin Act
2 150, section 71, is not repealed by 1999 Wisconsin Act 182, section 201. Both
3 treatments stand.

NOTE: There is no conflict of substance. As merged by the Revisor, s. 66.0225 reads:

66.0225 Municipal boundaries, fixed by judgment. Any 2 municipalities whose boundaries are immediately adjacent at any point and who are parties to an action, proceeding or appeal in court for the purpose of testing the validity or invalidity of an annexation, incorporation, consolidation or detachment may enter into a written stipulation, compromising and settling the litigation and determining the common boundary line between the municipalities. The court having jurisdiction of the litigation, whether the circuit court, the court of appeals or the supreme court, may enter a final judgment incorporating the provisions of the stipulation and fixing the common boundary line between the municipalities involved. A stipulation changing boundaries of municipalities shall be approved by the governing bodies of the detaching and annexing municipalities and s. 66.0217 (9) and (11) shall apply. A change of municipal boundaries under this section is subject to a referendum of the electors residing within the territory annexed or detached, if within 30 days after the publication of the stipulation to change boundaries in a newspaper of general circulation in the area proposed to be annexed or detached, a petition for a referendum conforming to the requirements of s. 8.40 signed by at least 20% of the electors of the area to be annexed or detached is filed with the clerk of the municipality from which the area is proposed to be detached and is filed as provided in s. 8.37. The referendum shall be conducted as are annexation referenda. If the referendum election is opposed to detachment from the municipality, all proceedings under this section are void. In this section, “municipalities” means cities, villages and towns.

4 **SECTION 22.** The treatment of 66.0227 (3) of the statutes by 1999 Wisconsin Act
5 150, section 66, is not repealed by 1999 Wisconsin Act 182, section 198. Both
6 treatments stand.

NOTE: There is no conflict of substance. As merged by the Revisor, s. 66.0227 (3) reads:

(3) The governing body of a city, village or town involved may, or if a petition conforming to the requirements of s. 8.40 signed by a number of qualified electors equal to at least 5% of the votes cast for governor in the city, village or town at the last gubernatorial election, demanding a referendum, is presented to it within 30 days after the passage of either of the ordinances under sub. (2) shall, submit the question to the electors of the city, village or town whose electors petitioned for detachment, at a referendum election called for that purpose not less than 42 days nor more than 72 days after the filing of the petition, or after the enactment of either ordinance. The petition

shall be filed as provided in s. 8.37. If a number of electors cannot be determined on the basis of reported election statistics, the number shall be determined in accordance with s. 60.74 (6). The governing body of the municipality shall appoint 3 election inspectors who are resident electors to supervise the referendum. The ballots shall contain the words “For Detachment” and “Against Detachment”. The inspectors shall certify the results of the election by their attached affidavits and file a copy with the clerk of each town, village or city involved, and none of the ordinances may take effect nor be in force unless a majority of the electors approve the question. The referendum election shall be conducted in accordance with chs. 6 and 7 to the extent applicable.

1 **SECTION 23.** The treatment of 66.0301 (1) (a) of the statutes by 1999 Wisconsin
2 Act 65, section 22, is not repealed by 1999 Wisconsin Act 167, section 38. Both
3 treatments stand.

NOTE: Section 66.0301 (1) (a) was renumbered from s. 66.30 (1) (a) by 1999 Wis. Act 150, s. 348. There is no conflict of substance. As merged by the Revisor, s. 66.0301 (1) (a) reads:

(a) In this section “municipality” means the state or any department or agency thereof, or any city, village, town, county, school district, public library system, public inland lake protection and rehabilitation district, sanitary district, farm drainage district, metropolitan sewerage district, sewer utility district, solid waste management system created under s. 59.70 (2), local exposition district created under subch. II of ch. 229, local professional baseball park district created under subch. III of ch. 229, local professional football stadium district created under subch. IV of ch. 229, local cultural arts district created under subch. V of ch. 229, family care district under s. 46.2895, water utility district, mosquito control district, municipal electric company, county or city transit commission, commission created by contract under this section, taxation district or regional planning commission.

4 **SECTION 24.** 66.0307 (10) of the statutes is amended to read:

5 **66.0307 (10) BOUNDARY CHANGE ORDINANCE; FILING AND RECORDING**
6 **REQUIREMENTS.** A boundary change under a cooperative plan shall be accomplished
7 by the enactment of an ordinance by the governing body designated to do so in the
8 plan. The filing and recording requirements under s. 66.0217 (9) (a), as they apply
9 to cities and villages under s. 66.0217 (9) (a), apply to municipalities under this
10 subsection. The requirements for the secretary of state are the same as those
11 required in s. 66.0217 (9) ~~(a)~~ (b).

5 town, or village may place any restriction, either directly or in effect, on the
6 installation or use of a solar energy system, as defined in s. 13.48 (2) (h) 1. g., or a wind
7 energy system, as defined in s. ~~66.0415~~ 66.0403 (1) (m), unless the restriction
8 satisfies one of the following conditions:
