

**SENATE SUBSTITUTE AMENDMENT 1,
TO 2001 ASSEMBLY BILL 711**

March 12, 2002 – Offered by Senator JAUCH.

1 **AN ACT** *to repeal* 3.003 and 3.01 to 3.09; *to renumber and amend* 3.002 (1);
2 *to amend* 3.001; and *to create* subchapter I (title) of chapter 3 [precedes
3 3.001], 3.002 (1m), 3.004, subchapter II (title) of chapter 3 [precedes 3.11], 3.11
4 to 3.18 and 13.92 (1) (b) 3. d. of the statutes; **relating to:** congressional
5 redistricting.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

9 **SECTION 10.** 13.92 (1) (b) 3. d. of the statutes is created to read:

10 13.92 **(1)** (b) 3. d. After passage of any bill that, if enacted, would create
11 congressional districts under ch. 3, in enrolling the bill for presentation to the
12 governor for approval, the legislative reference bureau shall attach to the bill an
13 appendix containing the population statistics for the congressional districts created
14 under the bill; a statewide map of the congressional districts created under the bill;
15 a map of the congressional districts created under the bill that are in Milwaukee
16 County; and, for any city, village, or town that, under the bill, is divided among 2 or
17 more congressional districts, except a city or village located in more than one county
18 if the district line follows the county line, a detail map illustrating the division of the
19 city, village, or town among the congressional districts.

20 **SECTION 11. Initial applicability.**

21 (1) This act first applies, with respect to regular elections, to offices filled at the
22 2002 general election.

23 (2) This act first applies, with respect to special or recall elections, to offices
24 filled or contested concurrently with the 2002 general election.
