3 2. Page 4, line 1: delete lines 1 to 4 and substitute:

4 "441.15 (2) (b) ~~Unless such~~ Except for home births, the practice occurs in a
5 health care facility approved by the board by rule under sub. (3) (c), ~~under the general~~
6 supervision of.

7 (bm) The practice occurs in collaboration with a physician with postgraduate
8 training in obstetrics and pursuant to a ~~formal~~ written agreement with that
9 physician.".

10 3. Page 5, line 11: delete "(b) ~~or, if that physician is unavailable, to~~" and
11 substitute "(b) ~~or, if that physician is unavailable, to~~".

4. Page 5, line 12: after "another physician" insert ~~the~~ (bm)".
